I/we understand a pre authorized credit card payment or 9 postdated cheques must be submitted within 3 days of registration to secure the dancers spot in the program(s). To withdraw from the program(s), 30 days written notice is required. Tuition will continue to be processed until a formal withdrawal notice is received. Payments late in excess of 7 days and/or NSF payments are subject to a \$25.00 processing fee.

***NEW* Funding may only be used for tuition (IE. JUMPSTART).** The family will be notified when the studio has received it and at such time, the funded amount will be credited to the account. Until funding arrives, tuition must be submitted on time and for the monthly amount owing.

I/we understand classes missed due to illness personal vacations will not be made up or refunded. Classes cancelled due to inclement weather are not subject to a make-up lesson unless otherwise decided upon by the teacher.

Studio closures due to inclement weather will be made known on the studio voicemail, website, Facebook page and Rock95 radio station.

Classes continue on the Saturdays and Mondays of all long weekends and holidays excluding Christmas and March Break.

I/we understand costume fees are due in full no later than Friday November 9th, 2018. Costume fees are non-refundable. Students are measured for their costumes in November and/or December and we allow for reasonable growth. These are not custom fit costumes and minor alterations are the responsibility of the family.

Late (after November 9th, 2018) registrants are subject to a late costume ordering fee of \$25.00 and cannot be guaranteed their costume for picture day.

I/we realize that participation in dance classes and activities could result in some possible personal injury. Despite precautions being taken by the studio, accidents and injuries may occur. By signing this release form, I/we (the dancer and parent/guardian) assume all risks related to the use of any and all spaces used by The Dance Academy of Barrie.
